Building Control Charges

Effective 10th October 2011

FEES ARE PAYABLE AS FOLLOWS:

- When Full Plans are submitted for approval a two stage charge is payable.
- The Initial Charge must accompany the submitted drawings and details. This covers the assessment of the proposed works and the passing or rejection of the plans. The Inspection Charge becomes due after the first inspection of work on site. An invoice will be sent for the inspection charge to cover all necessary site inspections including the completion inspection and certificate.
- If a Building Notice is submitted this must be accompanied by the relevant payment to cover the Building Notice charge. The charge covers all assessment and inspection procedures as above, but is payable in full at the time of deposit of the Building Notice. Building Notices charges are generally higher than the combined Full Plans Charges. This is to reflect the additional work involved when dealing with them.
- However, under certain circumstances a further charge may be payable where additional work and/or consultations have taken place. If consultants are used by this authority their costs will be passed onto the person having the work carried out, if not already included in the charge.
- The Local authority may agree to the payment of the charges by instalments. The amount and timing of instalment payments must be agreed in writing with the Local Authority prior to the submission of a Building Notice or Full Plans application.

Regularisation Applications: Subject to Quotation.

CHARGES ARE NOT PAYABLE FOR:

- Insertion of insulation material into an existing cavity wall, where installation is certified to an approved standard or is to be carried out by an approved installer.
- Work solely for the benefit of a disabled person.
- Where plans have been either approved or rejected, no further charge is payable on re-submission for substantially the same work.
- Informal consultations and advice on meeting Building Regulations and related standards are given free of charge for the first hour.

METHOD OF PAYMENT

- Payment can also be made by credit or debit card following receipt of your application. You will need to quote the credit card number, expiry date, security number and the house number and the post code of where the card is registered.
- Cheques should be made payable to 'South Bucks District Council'.
- On-line applications paid via World Pay.

Notes relating to Domestic Electrical Work

The Council will need you to provide certification of satisfactory testing and inspection for all electrical work that has been carried out by an electrician who is **not appropriately qualified/Part P registered** under the Competent Persons Scheme.

Any electrical installation undertaken by someone who is **not registered** with a self-certifying association (eg NICEIC, ELECSA, NAPIT etc) must provide an installation certificate, together with a test certificate prepared by a member of the NICEIC, ELECSA, NAPIT etc. For certain minor work, a lesser qualification will be accepted.

This requirement may unfortunately increase the cost of the application and may cause a delay as another electrician will need to be arranged to carry out an inspection and test.

If South Bucks District Council Building Control has to arrange this subsequent electrician, the minimum charge will be £225.00 including VAT.
